

Trust Deed

This the 14th (Fourteenth) day of January 2004

This Trust is called MAJLISU SHIKHAUSKHAFFIL ISLAMI situated at Manhampara of Adhur village, Kasaragod taluk represented by its Managing Trustee Sayyad Muhammad Ashrafi Sakhafi aged 40 years, agriculturist, son of Sayyad Aboobakar, Thangal Veettil of Adhur village, P.O.Kuntar 671 543 (Via) Mulleria, Kasaragod taluk has made this Trust witnesseth as follows:

1. This Trust is called as "MAJLISU SHIKHA USKHAFFIL ISLAMI TRUST"

2. The office of this is situated in Door No K.P.6.126 of Karadka Grama Panchayat.

3. Trust Fund : Presently the trustees have contributed Rs 15,000.00 totally and the same will be retained by the Managing Trustee. This fund will be increased with the help of

people and associations etc., in future which will be used

4. Administration of the Trust: The Trust will be functioned according to the rules and regulations framed in this deed by Trust Board.

5. Aims and Objects of the Trust :

(a) Eradication of poverty, illiteracy, providing proper shelter, education to the pupils of Yatheen/Khana and the people below poverty line.

(b) To provide basic knowledge in Khuran, Hadees, Fikh, Tasvuf, Thareeqah, Akhayid etc., and trying to perform in daily life.

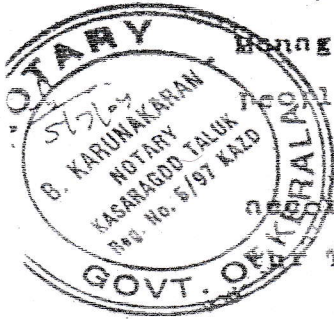
(c) To start Arabic College, Dars, Agathi Anaf Mandiram, Madrassa, School and other job oriented institutions, Computer Centre, residential school for the down trodden, Tuition Centre, Care centres etc.,

(d) To perform at the end of every month as a continuous process of conducting Dikarhalka, Swalath with the help of muslim scholars.

(e) To construct Mosques.

(f) To promote happy atmosphere among the castes.

(g) To uplift the financial conditions of the people below

(h) To wipe out the differences between the masses and make them unite for the betterment of the society at large.

(i) To work for eradication of misbelief, distrustive elements from the society.

(j) To help widows and other needy people.

6. This Trust will function irrespective of caste, creed, religion etc., And those who are interested to join as a member to this Trust shall levy a fee of Rs 101.00 and this will be varied from time to time as decided by the Board.

7. This Trust will not be dissolved or the Trust funds will not be distributed among the Trustees at any time. All the Trust funds will be utilised for the betterment of the aims and objects of the Trust in all respects.

8.(a) The administration of the Trust will be done by the following 5 permanent Trustees. The President is also in power for lifetime.

1. Sayyad Muahmmad Ashraff Sakaf son of Sayyad Aboobakar Thangal, Thangal House Manhampara, P.O.Kuntar, Mulleria, President, agriculturist, aged 42 years

2. Sayyad Musthafa Thangal son of Sayyad muhammad Koya Thangal, P.O.Kuntar, Mulleria (Vice President) agriculturist, aged 32 years

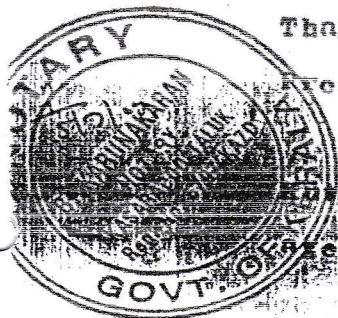
3. V.A.Naushad son of Alavi.V.Manhampara, P.O.Kuntar, Mulleria (General Secretary) agriculturist, aged 31 years.

4. Yousuf Moideen son of Moideen, Pudiya Puffa, P.O.Heroor Uppala (Joint Secretary) agriculturist, aged 33 years

5. Sayyad Yahiya Sakaf son of Sayyad Aboobakar Thangal, Manhampara, P.O. Kuntar, Mulleria, Treasurer, agriculturist, aged 41 years

(b) The President will have the veto power to nominate one or two trustees during the time of such situation arise.

9. All the Trustees shall be the citizens of India and they shall be residing in India. Any Trustee residing outside India



the interest of the Trust or mentally retarded, and live in sound mind but fails to attend three continuous Trust meetings, then he will cease as a Trustee. If any Trustee act against the interest of the Trust, then the majority of the Trustees will delete him as the Trustee from the Board. But he will be given an opportunity to narrate his grievances and only there after he will be deleted from his post.

(a) If any Trustee dies and if he nominate any trustee in his lifetime in writing and if he is abide by the rules and regulations of the Trust and activities of the Trust, then such person will be appointed as a new Trustee by a majority of opinion of the remaining trustees.

11. All the income derived by the Trust will be used for the betterment of the masses.

12. Separate sub committees will be formed for the betterment of various institutions to be established. These sub committees will come under the supervision of the Trust.

If anything wrong from these sub committees occurred which affect the Trust then the Board will take proper decision for the same. And in all financial transactions the name of the President or any person of his choice will be included. The sub committees will be in force for a period of one year.

13. If any of the Trustee act against the rules and regulations of the Trust, then the President will empower to take proper action thereof and oust such Trustee from the Board.

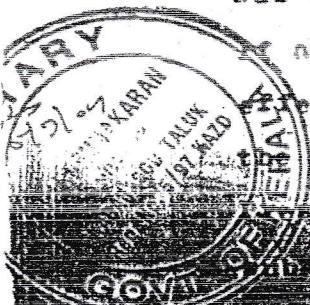
14. The bank account stands in the name of the Trust will be operated by the President or other trustees as decided by the President. And they shall perform the works of signing the cheque, making deposits and the like.

15. The Trust shall appoint an auditor and keep the upto date accounts of all transactions made from time to time.

16. The Trust shall maintain a minute book.

17. The committee will meet once in a year to form a new committee or make a decision to continue the present committee.

18. The same committee will be in force till the new committee will be formed.



19. The duties of the Managing Trustee cum President are as follows;

Presiding over all the meetings to be held, controlling the meeting, signing to the minute book, report book, rules and regulations passed, convening the meeting through proper notice through the Secretary, calling meetings directly in the absence of the Secretary or non co operation from the Secretary.

20. Duties of the Vice President:

Helping the President in the matters of the administration and presiding over the meetings and do all other works of the President in the absence of the President.

21. Secretary:

The controller of all the works of the Committee and all the efforts to be taken towards smooth working of the rules and regulations of the Trust from time to time. To preserve all the records, files, loss and profit account. To act as a liaison between the Trust and the General public, correspondences, the urgent matters will be discussed with the President and take proper decision accordingly and take the consent of the Trust in Trust meetings. Record all the decisions in the minute book. Preparing the report and read the same in the next meetings. The accounts in the form of assets and liabilities will be handed over to the Treasurer with due receipts and vouchers.

22. Joint Secretary :

Assisting the General Secretary and in the absence of the General Secretary his work will be made

23. Treasurer: Maintaining the monetary matters accurately

24. All the monetary transactions will be under the rules of 1961.

(b) The amount either in cash, kind, gift, donation etc., will be taken and preserved as capital fund of the Trust.

(c) All the Rules of Trust will come under the purview of Income Tax Act and the benefits thereof will affect the Trust

(d) Salary, cooli, rent, repair and construction of the building administered



(e) Appointment of the staff if required and leave them if not required.

(f) Any good project which will be beneficial to the trust will be taken into consideration and completed.

(g) If any rules or regulations will be added for the upliftment of the Trust and delete such of them which is not conducive in due course.

(h) Income Tax Exemption for the donations received will be made under Section 80G of Income Tax Act.
